

INDIA'S FOREIGN EXCHANGE RESERVES FELL BY \$5 BILLION IN THE WEEK TO JULY 1

India's foreign exchange reserves got depleted by \$5 billion in the week ended July 1, as foreign portfolio investors continued withdrawing investments from local equities leading to the rupee's slide to below 79 per dollar for the first time in history.

The Reserve Bank of India responded to the rupee's fall with steps to attract capital inflows on July 6, but the measures would take time to foreign currency demand-supply imbalance, economists said.

The reserves stood at \$588.314 billion as on July 1, RBI data showed. Out of this, foreign currency assets stood at \$524.745 billion while reserves held in gold were valued at \$40.422 billion. The balance is kept with the International Monetary Fund as special drawing rights and reserves.





FINANCE MINISTRY RELEASES REVENUE DEFICIT GRANT OF RS 7,183.4 CRORE TO 14 STATES

The Department of Expenditure, Finance Ministry on Wednesday released the 4th monthly installment of the Post Devolution Revenue Deficit (PDRD) grant of Rs 7.183.42 crore to 14 states.

The Fifteenth Finance Commission has recommended a total PDRD grant of Rs. 86,201 crore to 14 states for the ongoing fiscal. The recommended grant is released by the department in 12 equated monthly instalments.

The states who have been recommended PDRD grant during 2022-23 include Andhra Pradesh, Assam, Himachal Pradesh, Kerala, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Rajasthan, Sikkim, Tripura, Uttarakhand and West Bengal.

DELHI GOVT'S DEBT INCREASED BY 7% IN FOUR YEARS UP TO 2019-20: CAG REPORT

The Delhi government's debt increased by nearly seven per cent in the four-year period up to 2019-20 although it maintained a revenue surplus, according to a CAG audit report tabled in the Assembly on Tuesday. The debt increased by Rs 2,268.93 crore (6.98 per cent) from Rs 32,497.91 crore at the beginning of 2015-16 to Rs 34,766.84 crore at the end of 2019-20, said the report.

The Comptroller and Auditor General (CAG) report of the year 2021 on state finances for the year ending March 2020 was presented in the Assembly by Deputy Chief Minister Manish Sisodia.

The audit report on state finances provides an analytical review of the annual accounts of the Government of NCT of Delhi and functioning of Public Sector Undertakings for the year ending 31 March 2020.





RBI OKS INTERNATIONAL TRADE SETTLEMENT IN INDIAN RUPEES, TO MAKE INR MORE TRADABLE GLOBALLY

The Reserve Bank on Monday asked banks to put in place additional arrangements for export and import transactions in Indian rupees in view of increasing interest of the global trading community in the domestic currency. Before putting in place this mechanism, banks will require prior approval from the Foreign Exchange Department of the Reserve Bank of India (RBI), the central bank said in a circular.

"In order to promote growth of global trade with emphasis on exports from India and to support the increasing interest of global trading community in INR, it has been decided to put in place an additional arrangement for invoicing, payment, and settlement of exports / imports in INR," it said. For settlement of trade transactions, the concerned banks will require Special Rupee Vostro Accounts of correspondent bank/s of the partner trading country.

INDIAN STAFFING INDUSTRY ADDS 21.9% NEW EMPLOYMENT IN FY22: ISF REPORT

The Indian staffing federation has annually reported that the staffing industry has added 21.9% new workers in FY 2022 (April 2021 - Mar-2022), which will sharply exceed the workforce demand in the pre-pandemic years.

As per the findings that is part of the Flexi Staffing Industry Annual Report 2022 of Indian Staffing Federation, In Q4 FY2022, the Q-o-Q employment demand remained stable with 4.2% growth in Q4 (Jan-Mar 2022) as compared with Q3 (Oct-Dec 2021). The ISF represent 1.26 million members in formal employment in FY2022.

- FMCG, e-commerce, manufacturing, healthcare, retail, logistics, banking, energy drive general staffing are in great demand in FY22
- There is a 30.7% jump in newemployment in the IT staffing industry compared with 14.1% in FY2021, which is driven by digital adoption across sectors.
- Quarter 4 has experienced stable 4.2% employment growth in Jan-Mar 2022 vis-a-vis Q3 Oct-Dec 2021.
- Women's participation in flexi workforce continued at 27% in FY2022
- 15% of flexi workforce gets absorbed into permanent jobs
- Additionally, 5% students get added to flexi workforce YoY



TCS WORKFORCE CROSSES 600K MILESTONE, ATTRITION RATE RISES

India's largest information technology (IT) services firm Tata Consultancy Services (TCS) on Friday said its workforce stood at 606,331 as of 30 June, a net addition of 14,136 in the quarter.

The workforce continues to be very diverse, comprising 153 nationalities and with women making up 35.5% of the base, the company said in a statement.

"Our investment in strategic talent development initiatives and the linking of learning to career development have energised our workforce. Following our annual compensation review, employees received salary increases of 5% to 8%, with top performers getting even bigger hikes," said Milind Lakkad, chief HR officer, TCS.

"Our empowering, performance-driven work culture is helping us attract local talent across all our key markets. Continued hiring momentum resulted in a milestone quarter, with the employee strength crossing the 600,000 mark," he added.


