Save on Long-Term Capital Income Taxes (LTCG)

Since long-term capital gains are eligible for tax deductions under the Income Tax Act, you can save money on income if you follow certain rules. The main condition of the exemption is the reinvestment of the full amount in a residential property.

Before we get into the details of how to save capital gains tax in the long run, we need to understand what capital gains are and what the capital gains tax regime looks like. capital gains.

What is Capital Gains Tax

Capital gains are the profits an investor realizes when he sells his assets at a higher price than he bought them. "Capital" includes property such as land, vehicles and jewelry, stocks and securities held by a person.

Capital gains are taxable and there are 2 types of capital gains tax: short-term and long-term. Short-term capital gains arise from the sale of property held by the investor for up to 36 months (3 years) or stocks and bonds held for up to 12 months (1 year), while long-term capital gains are profits realized from the disposal of buildings held for more than 36 months and stocks and bonds held for more than 12 months.

Capital gains tax differs for short-term and long-term capital gains. Short-term capital gains not subject to securities transaction tax are added to income and taxed according to the income tax plates. If the income falls within the scope of the securities transaction tax, the tax rate is 15% in addition to the surtax and the school tax.

Long Term Capital Gains Taxes

Long Term Capital Gains Taxes (LTCG) for debt and equity funds are different. While equity funds do not attract long-term profit taxes, loan funds are subject to a 20% tax with indexation. Indexation refers to the process of calculating the cost of an asset by taking into account rising inflationary prices.

Although there is no tax exemption on short-term capital gains tax, long-term capital gains tax is subject to tax deductions. This means that you can legally save on long-term capital gains tax by following certain rules set out in the Income Tax Act. One of the main conditions for obtaining an exemption from the payment of capital gains tax is the reinvestment of the amount obtained from the sale of the property in a residential property.

Let's see the three main long-term capital gains tax exemptions:

Article 54: Concerns long-term capital gains on the sale of a dwelling and the reinvestment of the amount received, on another accommodation.

Section 54EC: These are long-term capital gains on the sale of a house and the reinvestment of the amount received, in specified bonds.

Section 54F: This is a long-term capital gain on the sale of any property other than a house and the reinvestment of the amount received for the purchase of a house.




